Complying with NHS Test & Trace	Players/ Parents/Carers / The wider community	Coaches must take a register of attendees to EVERY session and keep a copy for a minimum of 21 days in case the data is required by NHS Test and Trace.	Head Coach/ Lead Coach	At the start of every session
Players contact with each other during a session	Players/ Parents/Carers / The wider community	<ul> <li>Competitive training can take place for all participants, in an outdoor setting provided this takes place in groups of no more than 30 (including coaches).</li> <li>Competitive match play is permitted, with social distancing in place before and after the session, and in any breaks in play.</li> <li>When the ball goes out of play, it should not be retrieved by non-participants and should be retrieved using the feet rather than the hands where possible.</li> <li>Set plays: players are encouraged to avoid unnecessarily long setup or close marking. Other modifications apply to specific situations, such as goal celebrations being discouraged.</li> </ul>	Coaches, Players	During session

Parents/Carers contact whilst viewing training	Players/ Parents/Carers / The wider community	Parents/Carers will be asked to view from specific areas which will be a minimum of 10 meters away from the training session. Parents/Carers must observe 2-meter social distancing.	Lead Coach, Parents/Carers	During session
Contact with equipment	Players/ Parents/Carers / The wider community	<ul> <li>All setting out, collection and putting away of equipment is to be done by the lead coach only.</li> <li>The sharing of kit and equipment should be avoided and participants should bring their own drinks or refreshments, in named containers.</li> <li>The sharing of water bottles will be strictly banned, unless sibling use is approved by parents/carers.</li> <li>The sharing of kit and equipment should be avoided, but where equipment is shared, it must be cleaned before use by another person.</li> <li>Equipment to be sanitised upon completion of coaching sessions.</li> <li>Goal posts and corner poles should be wiped down before matches, after matches and at half time.</li> <li>Players/Parents/Carers are strongly encouraged to sanitise players footwear after a session.</li> </ul>	Lead Coach, Players	Before, during and after session
Contact during First Aid	Players/ Parents/Carers / The wider community	A member of the player's social bubble must remain on-hand to administer basic first aid if required. Members of the players social bubbles are encouraged to wait in their individual cars nearby. Spectator groups should be limited to six people per group and spread out in line with wider Government guidance.  If a member of the players' social bubble is unable to attend, that player will not be able to participate.	Lead Coach, Parents	Before session and during session
